1.0 INTRODUCTION/POLICY STATEMENT

- 1.1 All EAL learners have an entitlement to the full range of curriculum and extra-curricular opportunities such as educational trips, House activities and thematic days.
- 1.2 Their progress and attainment will be monitored by the LSCo/SENDCo/RSENDCo and reported to parents through the Campus' reporting procedures.

2.0 PURPOSE

- 2.1 The purpose of this policy is to provide a context for Campuses who admit students with English as an additional language.

3.0 SCOPE

- 3.1 This policy applies to every Campus within the OSGUK group where there are students for whom English is an additional language.
- 3.2 It is the responsibility of the Headteacher to ensure that the policy is implemented.

4.0 DEFINITIONS

5.0 POLICY STATEMENT

- 5.1 All EAL learners have an entitlement to the full range of curriculum and extra-curricular opportunities such as educational trips, House activities and thematic days.
- 5.2 Their progress and attainment will be monitored by the LSCo / SENCo and reported to parents through the Campus' reporting procedures.

6.0 PROCEDURES

- 6.1 EAL learners will be assessed by the LSCo /SENDCo/RSENDCo to determine their competency in English.
- 6.2 Following the assessments, an appropriate package of support will be put in place and this will be communicated to teaching staff. Students will be supported through learning support provision.
- 6.3 Teachers will plan teaching and learning activities to meet the needs of EAL learners in their classes. This will include:
- Differentiated resources to develop linguistic skills
 - Glossary of terms and key words
 - The use of visual images to reinforce written text
- 6.4 Teachers will monitor the progress of EAL learners and alert the LSCo / SENCo of any concerns.
